A meeting was convened to consider the letter received from Mr. Yogesh Kumar Gupta, Assistant Professor, department of Political Science & Nodal Officer for the persons with Disabilities. The following were present:

The following decisions were taken:

1. The error in English Department needs to be rectified.
2. The Staff council had decided that every teacher must be allocated minimum 10 lectures per week and accordingly the work load has to re-cast by making suitable amendments in number of tutorials recommended by work load committee. The matter needs to be immediately deliberated by the work load committee, so that the amended work load may be presented in the Staff Council for approval. It should be expedited so that the necessary steps for revised work load and Roster are implemented within 10 days.

3. The meeting recommends that the roster may be re-cast in the following manner: (200 hr roster)

No. of posts based on minimum of two (even or odd) semester should precede and should be followed by additional post generated by the maximum of the work load of two semesters (even or odd).
